The World Bank is providing non-lending technical assistance to the City Government of Addis Ababa (AACG) in subject areas related to its implementation of the transport aspects of its urban master plan (Promoting integrated urban planning in Addis Ababa to foster green growth or PIUPFGG). AACG has recently approved a change to its institutional governance structure in urban transport, which involves, among other things, the establishment of a Public Transport and Freight Authority (PTFA).
